FLASHING SIGNALS The Actor, Andrew BRETT , on or about, 02/04/2018, in the County of Clearfield, drove a motor vehicle, namely, gray Jeep Grand Cherokee bearing PA registration KJF-6213 , on a highway or trafficway, namely, Woodland Rd., and Daisy St. Ext. , Whenever a flashing red or yellow signal is used in a traffic signal or with a traffic sign it shall require obedience by vehicular traffic as follows:(1) FLASHING RED.üWhen a red lens is illuminated with rapid intermittent flashes, drivers of vehicles shall stop in the same manner as at a stop sign, and the right to proceed shall be subject to the rules applicable after making a stop at a stop sign as provided in Section 3323 (relating to stop signs and yield signs):(2) FLASHING YELLOW.üWhen a yellow lens is illuminated with rapid intermittent flashes, drivers of vehicles may proceed through the intersection or past such signal only with caution. , in violation of Section 3114(a)(1) and (2) of the Pennsylvania Vehicle Code, Act of June 17, 1976, as amended, 75 Pa. C.S. 3114(a)(1)&(2).



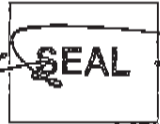



AFFIDAVIT of PROBABLE CAUSE CONTINUATION

I asked BRETT if he would submit to a PBT, which he refused. He then called and arranged for a ride from the hospital at my request. I placed him in handcuffs and into the back of my patrol unit for transport to Penn Highlands Clearfield. BRETT'S vehicle was removed from the roadway and parked in the parking lot of Kurtz Brothers, by PSP troopers with his permission.

I then transported BRETT to Penn Highlands Clearfield. Once in the admissions area I read BRETT his chemical test warnings from a DL-26B. BRETT signed indicating that he had been advised of the warnings. Hwever, he refused to give a blood sample. He was then released to a responsible party from the hospital.
