AFFIDAVIT of PROBABLE CAUSE CONTINUATION

I asked BRETT if he would submit to a PBT, which he refused. He then called and arranged for a ride from the hospital at my request. I placed him in handcuffs and into the back of my patrol unit for transport to Penn Highlands Clearfield. BRETT'S vehicle was removed from the roadway and parked in the parking lot of Kurtz Brothers, by PSP troopers with his permission.

I then transported BRETT to Penn Highlands Clearfield. Once in the admissions area I read BRETT his chemical test warnings from a DL-26B, BRETT signed indicating that he had been advised of the warnings. Hwever, he refused to give a blood sample. He was then released to a responsible party from the hospital.
